U2G Notes:

- Up to **16 semester hours** of MFin coursework that is taken in the U2G year could be applied to the undergraduate semester hours needed for your bachelor's degree.
- FIN:9400 Professional Development Business Acumen may be taken in fall or spring in the U2G year and in the opposite semester in the grad year.

<u>Registering</u>: Log into MyUI (<u>https://myui.uiowa.edu/my-ui/home.page</u>) with your HawkID and password. Click on *Courses/Registration* in the yellow bar at the top and search for courses. Click the *Enroll* button to register.

Finance U2G course waivers and substitutions

- Finance U2G students should take FIN:3000 + FIN:3300 and waive MBA:8180.
- Finance U2G students should take ACCT:3020 instead of MBA:8140. If taken prior to the U2G year, MBA:8140 will be waived. If a student receives a C or lower, MBA:8140 will be recommended. If the U2G student takes ACCT:3020 in the U2G year, then it will count as credit toward the MFin.
- If BAIS:2800 has not yet been taken, BAIS:9100 can be used to fulfill the undergraduate requirement of BAIS:2800.
- Undergrad finance elective hour requirements could be fulfilled by taking FIN courses numbered 9000 or higher, MBA:8170, or BAIS:9100 in the U2G year.
- If FIN:3200 has not yet been taken by the U2G year, take FIN:9200.

One waiver from the following is allowed if you had an A– or better in the following Tippie undergrad course. The equivalent undergraduate course must have been taken prior to beginning the MFin Program (i.e. not in the U2G year).

- FIN:4210 Futures and Options waives FIN:9210 Derivatives
- FIN:4220 Fixed Income Securities waives FIN:9220
- FIN:4250 Applied Equity Valuation waives FIN:9150

*For non-Tippie students, a similar waiver may be possible if review of a submitted syllabus demonstrates a comparable course and an A-or better is received.

Course waivers for non-finance majors

- MBA:8140 Corporate Financial Reporting: accounting majors with a minimum 3.3 major GPA or with CPA or CFA level 1.
- MBA:8170 International Environment of the Firm: economics majors with a minimum 3.3 major GPA.
- BAIS:9100 Data and Decisions:
 - For a Tippie undergraduate: the student received a grade of B or better in one of the following courses and an A– or better in at least one:
 - BAIS:2800 Business Analytics or ECON:2800 AND
 - Another class that uses Excel and statistics, including MKTG:3100 Marketing Research, ACCT:4100 Auditing, BAIS:3500 Data Mining, BAIS:3800 Optimization and Simulation Modeling, or ECON:3355 Econ and Business Forecasting. Request approval for additional coursework from advisor.
 - For non-Tippie undergraduate analytics majors: a minimum 3.3 major GPA may also waive BAIS:9100.

**Course waivers do not reduce credit hours; the waived course is replaced by an additional elective. To receive a waiver, contact your advisor prior to the start of the first semester.

Note that not all FIN courses are offered every year.
