- Completion of four prerequisite courses with a 2.75 GPA and no grade below C¹
- A cumulative GPA of 2.75²
- Completion of an online application by May 1 for fall admission or December 1 for spring admission (subsequent summer courses will not be considered in the fall admission decision.)
