

# Oakton Community College, Des Plaines, IL courses that satisfy University of Iowa Business requirements

The following requirements must be met to be considered for admission to the [Tippie College of Business](#):

- Completion of four prerequisite courses with a 2.75 GPA and no grade below C<sup>1</sup>
- A cumulative GPA of 2.75<sup>2</sup>
- Completion of an online application by May 1 for fall admission or December 1 for spring admission (subsequent summer courses will not be considered in the fall admission decision.)
